1. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Bidder to provide leaflets/brochures of the offered products.
2. Bidders should submit/comply with the mandatory specification as requested in Buyer Added Bid specific.

### 5. Generic

The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. The goods for which bids have been invited fall under classification of GST concession and the conditions for eligibility of concession are met by the institution.
